**Training Process:**

All staff—licensed and classified—will receive trainings both virtually and face-to-face on the information and procedures contained in this document prior to students returning for instruction. We have run both an emergency daycare during the spring and on-site summer school, so our district has had the opportunity to test out many of our protocols and refine practices. The entire Early Learning Center and Welcome Center staffs have already trained in our health and safety protocols as we used this site and these staff members for both the Emergency Child Care and on-site summer school.

**Reporting to LPHA:**

Logs of students/staff sent home due to COVID-19 symptoms and contact tracing information will be sent to Marion County Health Authority as needed and follow their recommendations. The district has already had the opportunity to engage in this process due to situations reported during summer school.

**Isolation:**

All schools in the district will use an unused room in the daycare building as a central isolation location. For those students who need to be driven to that location the district will use the small Type 20 bus to transport. The room will be supervised by a classified staff member who will remain with students until they are picked up. The staff member will be wearing PPE provided by the district. Upon pick-up the District will provide written notification as to what needs to be provided to the district before the student may return.

**Logs and Tracking:**

- Daily attendance logs for each cohort will be maintained, to include; classroom, transportation, recess, etc.
- Logs will be kept in each building office until the end of the school year.
- Logs shall include: Child's name, drop off/pick up time, Parent/guardian name and emergency contact information
- All staff (including itinerant staff and substitutes) names and phone numbers shall be logged along with their cohort interactions.

**Screening:**

- Each cohort shall be assigned an entry location. Staff will be assigned to each location and will screen students each morning prior to entering the building.
- When the screening indicates that a student may be symptomatic, the student will be directed to the office where the staff will follow the isolation and screening protocols identified in the pandemic and COVID-19 plan, and directions provided by Marion County Health Authority will be followed.

We require staff to take temperature of all entering children and other individuals coming into contact with a stable group. If they have a temperature of 100.4 Fahrenheit or over, they must be excluded. Staff may self-screen and attest to their temperature on a daily basis.</p> <p>Parent and student protocols are read and signed by each family signifying their agreement and compliance with the infection control measures.
