#### 8.3 Resolution for Masking

## **Comments:**

Ms. Stevens said that the district did a survey, and the results said that 72% were okay with the option of wearing a mask, and 28% said that they would continue to wear a mask even if it is not required. Individuals commented on how the district plans to support kids to feel comfortable if they choose to wear a mask. Ms. Stevens said that she has been working with administrators to prepare students in the classroom to talk about the option to mask in the coming week and how to respect other people's choices. She said that she feels comfortable moving forward. In addition to talking with students, communication will go out to parents explaining the process after parent-teacher conferences. Ms. Stevens informed the group of requirements regarding unvaccinated individuals and volunteers. She added that parents would continue to get notified if their child is exposed, but individuals will no longer have to quarantine. She stated that anyone with symptoms will still be encouraged to stay home. She said that she feels the district has a good handle on this. She said that they also looked at the high needs population, and they were all comfortable with having a choice. The students will continue to wear tracer badges with GMS and GHS and do cohorts at elementary school.

There was a motion made by Director A. Contreras and seconded by Director M. Caballero that the Gervais School District #1 Board of Directors approve the resolution for masking, as read by Director Bustamante. The motion passed 4-0. (Director Toran was absent)
