REGULAR SESSION

Director A. Contreras called the School Board of Gervais School District #1, Marion County, into a Regular Session on Thursday, September 15, 2022, at 8:27 p.m. Board members present included: Maria Caballero, Ana Contreras, Maria Contreras, and Angie Toran (Director Bustamante was absent). 1.0 CALL TO ORDER

1.1 Pledge of Allegiance

Director A. Contreras called the School Board Meeting to order at 8:27 p.m.

Director A. Contreras asked the public if they signed up to speak to make sure that comments were kept brief and concise and to keep comments to a time limit of three minutes.

Announcements:

Ms. Stevens distributed back-to-school bags to the school board members, including items donated by different organizations that partner with the district.

There was a reminder about signing up for the blood drive coming up. Unfortunately, not many donors signed up due to all the week's athletic activities. Ms. Steven said she would pass on the information so board members could share it with the community.

3.0 APPROVAL OF MINUTES

Director A. Contreas asked the board members if they had any corrections to the board minutes from Working Session on August 15, 2022, and the Regular Session on August 18, 2022.

4.0 PUBLIC FORUM:

Mark Chase.

Mr. Chase (Gervais Police Chief) stated that he appreciates the current partnership with the district and the collaboration with the superintendent, administrators, and staff to keep schools safe for students. He talked briefly about how the Gervais police department supported the district by patrolling the safe schools and shared that the DARE program will start soon with the 8th graders. Finally, Mr. Chase told the group that legislators must be educated on how important it is to keep safety officers in the schools and not eliminate funding as will likely be proposed at the 2023 legislative session.

Financial Report:

Ms. Davis shared that she provided a couple of reports in the board packet that she would like to discuss further.

Ms. Davis shared the following about the two reports:

Financial Reports

- She provided financial reports with financial summaries by function/object for the general fund and the special revenue actuals for 2020-21, 2021-22, and 2022-23 for comparison.
- Dollar amounts are higher for 2020-21 actuals in the general fund due to the amount that the district received for food services.

Budget Calendar for 2023-24

Oregon Medical Paid Leave

- More information will be provided at the next regular session in October.

Superintendent Report:

Ms. Stevens said that in her written report, she included some budget scenarios comparing last year to this year. Numbers are, and the reality is that the numbers were increased compared to the previous year. So, it comes down to that you borrow less, and taxpayers pay more. Mailings will go out in October to registered voters, and some will be targeted in certain precincts numbers with Gervais votes in the last bond vote. She expressed that now that she has the city council members' support, she will reach out to them for help. Ms. Stevens shared with the board members that the annual OSBA conference on November 11-13, held at the Portland Marriott, is coming up. If any wish to attend, contact Ms. Segura to get registered. Comments:

Ms. Stevens expressed that if the board is not comfortable with adopting the policies tonight, they could go for a third reading next month for approval.

The school board members had further clarification questions on the following policies:

BCF: Advisory Committee to the Board

Director A. Contreras asked if the pre-bond committee would follow the pattern of the advisory committee's process.

Ms. Stevens replied that what is embedded in that policy is the educational advisory equity committee, which is a new component passed by the legislative body during the last big session, it clarifies the requirements for district's less than and with more than 10,000 students. The district is already doing this work with the Equity Lens Committee and it is part of the Strategic Plan. When the lens gets flushed out, there will be more of an equity committee. Right now, the district is not required to have it.

CBC: Superintendent's Contract

Director Ana Contreras asked for clarification of whether the district would have to provide health benefits for a superintendent that is no longer employed by the district until he/she reaches 65 years of age.

Ms. Stevens said that health benefits would have to be paid to the superintendent, not the district.

CPA: Layoff and Recall for Administrators

Director Maria Contreras asked for further information on what it looks like to lay off administrators.

Ms. Stevens explained the bumping process in detail.

JGAB: Use of Restraint or Seclusion**

Director A. Contreras asked about the language 'impeding breathing". What will happen if there is an order to wear masks again?

Director M. Contreras asked about the language, "the district shall investigate all complaints regarding the use of restraint and/or seclusion practices according to the outlined in Board Policy KL." She wondered where that procedure is located on the district website?

Ms. Stevens said that a mask is not restraining the person from breathing and thinks an attorney would be able to challenge that. "restraining" means another person is touching the individual and may physically impede the breathing. Ms. Stevens said that it should be in the "Special Education" section of "504" when it gets updated since the policy has been updated recently. She will ask Dr. Helms to have it posted on the district's website.

Director A. Contreras asked what the language means: "mutually monogamous relationships with an uninfected partner for adults"? She stated that language is concerning to her.

Ms. Stevens said that she would follow up with OSBA and get back to her.

The board members showed appreciation for the district's great teachers and for putting up with the aging facilities. The board members said they felt sad after doing the walkthrough and not being able to offer the students better buildings, but they felt that there was some progress.
